### **Subjects of Investigation:**

BioNTech/ Pfizer/ Fosun Pharma/ Rentschler Biopharma; Moderna/National Institute of Allergy and Infectious Diseases (NIAID)/Biomedical Advanced Research and Development Authority (BARDA)/ Lonza/ Catalent/Rovi/ Medidata/ BIOQUAL; Janssen Pharmaceutical Companies/Johnson & Johnson / Emergent Biosolutions; Wuhan Institute of Biological Products; The National Institutes of Health (NIH); The Centers for Disease Control and Prevention (CDC); US Department of Health and Human Services; Dr. Anthony Stephen Fauci; Chinese Communist Party (CCP); et al

Dear Attorney General Schmitt:

This communication is to serve as my referral to your office, for purpose of possible criminal prosecution under the Racketeer Influenced and Corrupt Organizations Act "RICO" Federal statutes, along with the related Missouri criminal code, the above-named entities/individuals, along with others, identified during an investigation by your office.

For purposes of identification, as to the undersigned investigator referring this to your office, my name is Wayne Warrington. I am a 40-year veteran of the investigative industry, serving 20 years as a senior and intelligence contract investigator for multiple Federal Agencies, along with dozens of the largest financial institutions in America. During the first 20 years, I supervised, or conducted directly, over a thousand cases involving matters of financial fraud, civil and criminal background investigations, and cases dealing with organized crime activity. The second half of my professional career has been as a Consumer Advocate serving millions of Americans, without charge, assisting them with the recovery of hundreds of millions in property. As full disclosure, I am not a medical doctor, nor scientist, or licensed attorney and therefore the conclusions reached within my investigation dealing with the efficacy of the Coronavirus, along with the mRNA injections used/created/promoted by the subjects of the investigation, are conclusions that have been reach by, and made public by, eminently qualified experts within their respective fields of medicine and science. My conclusions deal directly with the fact that the above referenced subjects of this investigation are believed to have colluded, worked in concert with one another, or have profited or advanced themselves to the detriment of millions of citizens within your state, costing lives and loss of health, livelihood, and property, all of which I believe fall within the definition of criminal activities that can be prosecuted under the Federal RICO Act.

The reason I am writing to you, as well as other Attorney Generals across the United States, is I believe at this time the U.S. Department of Justice (DOJ) may not be able to act with the urgency needed to save millions of lives, including citizens within the State of Missouri. Governor Mike Parson, along with yourself, are uniquely qualified, and have authority, to put a stop to the crimes being committed against those living in your State. It is my opinion that each State, must fully use the laws within their State Constitution and the US Constitution to preserve and protect their citizens, as well as apply the Federal RICO Act, if possible, along with your State Criminal Code as appropriate, to prosecute entities that are engaged in criminal activities that fall under their respective titles. Your state's ability to prosecute federal crimes maybe limited, yet your state's responsibility to protect your citizens should provide you with justification for every effort to be taken to stop these experimental Covid injections.

The Racketeer Influenced and Corrupt Organizations Act (RICO) was adopted in 1970. As defined with the Department of Justice's Website, *"The **RICO statute** expressly states that it is unlawful for any person to conspire to violate any of the subsections of 18 U.S.C.A. § 1962. The government need not prove that the defendant agreed with every other conspirator, knew all of the other conspirators, or had full knowledge of all the details of the conspiracy."*

As a consumer advocate I have spent the last 20 years protecting consumer rights. One of the key elements' "benefits" of the RICO laws, for those injured, or for the families of those that lost their lives from the criminal activities, is the ability of the courts to freeze the assets of those entities involved or benefiting from the illegal activities. Simply put, I recommend that your office take every step necessary to secure the assets of the Defendants (Subjects of the Investigation) that you deem appropriate, within your state's authority. Real Property, Personal Property, Financial Accounts, Stockholdings, etc. These assets should be used to compensate the citizens of your state that have been damaged in any way.

To be clear, due to the lack of transparency by departments within Federal Government, the CDC, the NIH, the related pharmaceutical companies, and other entities/organizations that could potentially be held responsible for the crimes I believe to have been committed, this case has taken many months to piece together. I, like most Americans in 2020, put full faith and credit into the information being released by The White House, the Coronavirus Task Force, Media Outlets, NIH, and the CDC. Unfortunately, what I have uncovered is what I genuinely believe to be one of the largest and most elaborate organized crime operations in the history of our country.

It is obviously up to your office to determine, that it is possible under Title 9 (*18 U.S.C.A. § 1961-1968*); or your state's criminal code, that any individual, company, media outlet, or organization that continues to promote the administration of the Covid-19 experimental injections "vaccines" after becoming advised/aware of the adverse effects of the shots, including death and/or permanent injury, can or should be held accountable and financially liable under the RICO Act to all those injured.

I have compiled over 6 gigabits data and testimony, thousands of pages of documents covering the injuries and deaths, I have reviewed hundreds of hours of video evidence by highly qualified medical experts, doctors, scientists, as well as those directly able to testify as to the dangers of the Covid-19 experimental injections as well as other activities which I believe clearly represent criminal activities that fall within the 35 defined elements of RICO. I am willing to provide your office with any assistance needed in preparation of the RICO prosecution memorandum in the criminal cases against those determined to be involved in crimes against the citizens of your State.

You should be aware of the number of deaths in your State of individuals that were treated in hospitals for the Covid-19 virus, along with the deaths and injuries of your citizens from the injection of the experimental "vaccine" shots, and you are aware of the financial devastation to your citizens and small business owners within your State. Instead of laying out hundreds of pages of the investigative process and details of thousands of injuries/deaths of citizens within your State, I am simply providing what is required under the RICO laws to establish the criminal activity which can be pursued by your office to protect and preserve the lives of your citizens. Based upon my experience serving as a senior investigator working with the Criminal Justice system, I am confident that this information is sufficient for your office to take every step needed to immediately end this criminal activity and bring to justice those that have benefited in any way from the events of the past two years.

I realize that the complexity of the criminal activity described herein, along with the fact you could be dealing with both federal and state crimes with hundreds of defendants in this matter can make the process difficult and potentially require multiple case filings, not to mention the potential for class action litigation to secure compensation for all those adversely affected.

In any event, the first step is to protect the residents of the great state of Missouri and put a stop to all Covid-19 experimental injections. Each new injection is proving to become a potential death sentence to the individual relying upon protection from your office and that of the Governor Mike Parson. Every one of your citizens has the right to informed consent which is an inalienable and universal human right. American citizens of Missouri have been lied to, manipulated, and it is time to end this attack upon our freedom and our democracy.

**SUMMARY OF ALLEGED CRIMINAL ACTIVITY:**

1. During the years 2020, 2021 and 2022, the Subjects of the Investigation created, caused, promoted, extended, or used the existence of the Coronavirus “Covid-19” to promote, extend and/or profit from a declared pandemic to incite fear, terror, financial damage, and in thousands of cases death, upon the citizens of the State of Missouri.

3. During the years 2020, 2021 and 2022, the Subjects of the Investigation colluded to discredit the professional and expert opinions, testimonies, reports, or scientific/medical findings of eminently qualified individuals whose work and efforts could have saved thousands, if not millions, of lives.
4. During the years 2020, 2021 and 2022, the Subjects of the Investigation created, enhanced, promoted, distributed, or administered a highly toxic and dangerous experimental injections, under the guise of the injection being “a safe vaccine”, to millions of citizens within the State of Missouri, with the knowledge of the injection’s adverse effects for those being injected.
5. During the course of 2020 and 2021, the Subjects of the Investigation provided false information, testimony, reports and other information to governmental agencies/groups, and congressional members/committees, in order to entice citizens within the State of Missouri to be subject to an experimental injection that has been proven to cause sever adverse events, while the Subjects of the Investigation benefited financially into the billions of dollars.

Much of the above criminal activities have been classified/deemed by hundreds, if not thousands, of Globally renowned experts, medical professionals, doctors, and scientists, as being nothing less than a total departure from the standards of care for patients and what citizens of Missouri have come to rely upon to keep them safe and healthy, as well as breaches of their human rights and international laws such as the Nuremberg Code. And quoting from their recent Cease-and-Desist Notification, *“There is now more than enough evidence on the [UK] Yellow Card system to declare the COVID-19 vaccines unsafe for use in humans. ## DECLARATION, CEASE AND DESIST AND NOTICE OF LIABILITY

### **WORLD COUNCIL FOR HEALTH CALLS FOR AN IMMEDIATE STOP TO THE COVID-19 EXPERIMENTAL "VACCINES"**

#### **A. CONSENSUS OF WORLD'S FOREMOST EXPERTS**

Globally renowned experts, including Dr. Paul Alexander, Dr. Byram Bridle, Dr. Geert Vanden Bossche, Prof. Dolores Cahill, and Drs. Sucharit Bhakdi, Ryan Cole, Richard Fleming, Robert W. Malone, Peter McCullough, Mark Trozzi, Michael Yeadon, Wolfgang Wodarg, and Vladimir Zelenko, among many others, consistently warn the world about the adverse effects resulting from Covid-19 experimental injections; they also warn about their long-term effects, which cannot be known at this time since most clinical trials will be not completed until 2023, and some as late as 2025.

In June 2021, Dr. Tess Lawrie, co-founder of the World Council for Health and member of the Council's Steering Committee, courageously described the global crisis and called for urgent action: *"There is now more than enough evidence on the [UK] Yellow Card system to declare the COVID-19 vaccines unsafe for use in humans. Preparation should be made to scale up humanitarian efforts to assist those harmed by the COVID-19 vaccines and to anticipate and ameliorate medium to longer term effects."*

#### **B. DECLARATION**

The World Council for Health declares that it is time to put an end to this humanitarian crisis. Further, the Council also declares that any direct or indirect involvement in the manufacturing, distribution, administration and promotion of these injections violates basic principles of common law, constitutional law and natural justice, as well as the Nuremberg Code, the Helsinki Declaration, and other international treaties.
